Nebraska's System Step Up to Quality

- LB507 passed in 2013 establishing *Step Up to Quality*
- Implemented jointly Nebraska Department of Health & Human Services and the Department of Education
- Five steps to quality
 - Step #1 state licensure
 - Step #2 coaching available
 - Steps #3, #4, #5 financial incentives, technical assistance, and tiered reimbursement available
- Required providers enroll during the first three years (2014, 2015, 2016) as outlined in legislation other providers may enroll voluntarily
- Ratings go public in 2017

Required Participation in Step Up to Quality

- *Year 1:* July 1, 2014 December 31, 2014
 - Programs/providers who receive \$500,000 or more annually from the child care subsidy
- *Year 2:* July 1, 2015 December 31, 2015
 - Programs/providers who receive \$250,000 or more annually from the child care subsidy
- *Year 3:* July 1, 2016 December 31, 2016
 - Programs/providers who receive \$250,000 in the preceding fiscal year or six months after receipt of assistance, whichever is later

Basic Framework for Evaluation

- The timeframe for collection of data
 - January 2015 December 1, 2015
- The collection of data will overlap asking for it to be reported in two phases
 - Preliminary findings on Phase #1: 4-30-15
 - Preliminary findings on Phase #1 & #2: 12-1-15
 - Final report due: 2-1-16
- Keep information separate:
 - Required participants from voluntary participants

What We Want To Know

- How many participants are enrolled?
- How many total children do they serve and how many are on the child care subsidy?
- At what step did the participants enter?
- How many have utilized incentives?
- How many have moved up a level since enrollment?
- What are the barriers to upward movement?
- What is the level of interest for voluntary participation?
- How many parents have heard of Step Up to Quality?

Timeline

- Proposals due November 24, 2014
- Notification of award December 15, 2014
- Contract begins January 2, 2015
- Preliminary findings (#1) April 30, 2015
- Preliminary findings (#1 & #2) December 1, 2015
- Final report due February 1, 2016

Proposal Requirements

- No more than 10 pages including budget
- Supporting documentation listed as appendices
- Submit electronically November 24; 5:00 p.m.
- Available funding \$150,000
- Indirect costs limited to 10% of the request
- Funds distributed:
 - One-third upon contract signatures (January '15)
 - One-third upon submission of Phase #1 findings (May '15)
 - One-third upon submission of Final Report (February '16)

Scoring Criteria

- Approach and design of the evaluation (40 points)
- Evaluation team qualifications and experience (30 points)
- Budget proposal (30 points)
- Conceptualize and suggest questions for a Phase #3 evaluation (extra 10 points)
